1. Background

This Memorandum of Understanding (MoU) made between two organizations provides for the establishment of mutual co-operation between these two institutions.

3. Duration and Termination

This MoU may be terminated at any time during its term by either **Wallet Finserve Pvt Ltd or DSBM** upon one-months prior written notice to the other.

4. Specific areas of co-operation

Wallet Finserve Pvt Ltd & DSBM to work together in the following areas:

- 4.1 Joint Partnership Programmes for supporting educational research projects, workshops, customized training & development sessions and financial literacy programmes etc. in order to enhance the employability skills both of the Commerce & Management students of BBA, B. Com and PG Programmes.
- 4.2 Summer Internship Programmes for students of BBA, B. Com and PG Programmes as per the university curriculum subject to availability of slot.

Other areas of co-operation 5.

DSBM and Wallet Finserve Pvt Ltd will also explore other potential areas where co-operation would be of exclusive mutual benefit of the students' community.

Intellectual Property Rights 6.

All intellectual property content that is developed jointly by the Parties 6.1 after the commencement of this MoU will be jointly owned by the Parties and subject to any other terms and conditions that will be worked out on a case-to-case basis, as may be agreed upon in writing.

Good Faith 7.

The parties declare it to be their intention that this MoU shall operate 7.1 between them in accordance with the principles of good faith, with fairness and without detriment to the interests of anyone.
